It consists of a series of classes, held once each week for three hours. The instruction is comprehensive, covering a different area of the police department each week. Officers, supervisors and personnel assigned to that particular division conduct each instructional block.

Who May Attend?

The class is made up of a cross section of the Stephenville community.

Doctors, architects, professionals, laborers, students, secretaries, salespersons, retirees and others are encouraged to apply for admission. The academy is held once a year in the Fall.

The minimum age for enrollment is 21 and you must live or work or in the City of Stephenville.
